



# D01 Awards:

- 1. Dr. John C. Weaver Excellence in Leadership Award Technical Committee Award
  An award given to recognize outstanding contributions and years of service in Committee D01 and commitment to the advancement of standards.
- 2. Leonard Schaeffer Memorial Award Technical Committee Award recognition of your sustained outstanding competence in the technical aspects of Committee D01 and your continued support of efforts to develop international standards.
- 3. Lifetime Excellence and Appreciation Award The Lifetime Achievement Award is to recognize lasting and significant contributions and exceptional service over many years to Committee D01, its subcommittees and/or activities. It is the highest award presented by Committee D01. The award may be granted posthumously.
- **4. Award of Excellence** for outstanding contributions and demonstrated leadership in the development of standards.
- 5. Robert J. Painter Memorial Award- (established 1925) the ASTM International President's Leadership Award.
- 6. Society Honorary Member- which requires election by the ASTM Board of Directors.
- 7. Outgoing Chair Award- a member who has completed their term as Chair.
- **8. Award of Appreciation** This award was established in 1998 to recognize significant contributions to Committee D01, one of its subcommittees or one of its activities. The contribution may be for a significant specific effort or for consistent contributions of a sustained nature over a period of time.
- 9. Honorary Committee Member- Regular members of the Committee who have rendered long and meritorious service to the Committee may be proposed for honorary membership in the Committee by Subcommittee D01.94 on Awards and Memorials and then approved by the Executive Subcommittee and the Committee, with no change in the rights and duties of that member.
- **10.** Henry A. Gardner Subcommittee Chair of the Year Award The Henry A. Gardner Award is presented not more frequently than once a year to a member of ASTM Committee D01, who has demonstrated sustained outstanding competence in managing a unit of D01 so that its productivity is high. The award, established in 1977, honors Dr. Henry A. Gardner, Sr. an honorary member of D01.

Dr. Gardner, 1882-1973, was the epitome of successful management of people and problems in furthering the broad technical objectives of the paint industry, i.e., he exemplified this award. As Director from 1909 of the Scientific Section of me forerunners of the present National Paint and Coatings Association, he both operated complex research programs and participated in the early cooperative test programs of ASTM Committee D01. He chaired various D01 task groups and subcommittees, was D01 Vice Chair in 1919-19C28, and later was elected an Honorary Member of Committee D01. He gained world-wide fame through publication of twelve successive editions of "Physical and Chemical Examination of Paint, Varnishes, Lacquers, and Colors," known as the Paint Testing Manual or "bible", and

then donated its copyright to ASTM, who revised and reissued it as a thirteenth edition, STP 500 in 1972, perpetuating his name.

## RULES GOVERNING THE HENRY A. GARDENER SUBCOMMITTEE CHAIR OF THE YEAR AWARD

The Award shall be administered by a Gardner Award Group consisting of three members of Committee D01 appointed for three-year staggered terms. An appointment of a new succeeding member shall be made annually by the Chair of D01 not later than June 30. The senior member of the Group shall serve as its Chair, and the Group shall report administratively to Subcommittee 94 on Awards and Memorials.

Each year the Gardner Award Group shall consider the eligibility of committee members for the award and shall nominate a recipient for the approval of Subcommittee 94 and the D01 Executive Committee at its annual January meeting. Members shall not be eligible while serving. The Award Group shall notify the Secretary of Committee D01 of its nomination at least two months prior to the meeting and the nomination shall include the name and address of the recipient and a suitable inscription for the certificate.

The Gardner Award Group shall make the arrangements for securing and presenting the Award.

The D01 Executive Committee shall have the authority to decide any questions not specifically covered by these rules, and the rules may be modified upon recommendation of the Gardner Award Group. The Gardner Award Group shall administer the endowment fund.

# **AWARD TO RECIPIENTS**

The Henry A. Gardner Award shall consist of a certificate and a cash honorarium consisting of the rest of the proceeds from the endowment. The wording of the inscription of the certificate shall be as shown as follows:

Established in 1977 by Committee D01 in honor of Dr. Henry A. Gardner, Sr., and given in recognition of outstanding contributions in the operations of (proper unit)

## **FUNDING**

Financing of the award is through an endowment by Gardner Laboratory, Inc.

## 11. William T. Pearce Award – Society Recognized Award-

The William T. Pearce Award is presented not more frequently than once a year to a member of Committee D01 on Paint and Related Coatings and Materials, who has performed outstanding work and has had published within the last 5 years a technical paper of merit relating to the science of testing paints and paint materials. The award established in 1969, honors Dr. William T. Pearce who was a member of Committee D01 for over 45 years and who served as its Chairman for 20 years.

#### RULES GOVERNING THE WILLIAM T. PEARCE AWARD

- A The award shall be administered by an Award Task Group consisting of three members of Committee D01 appointed for three-year staggered terms. An appointment of a new succeeding member shall be made annually by the Chairman of D01 not later than June 30. The senior member of the task group shall report administratively to Subcommittee 4 on Awards and Memorials.
- B. Each year the Award Task Group will consider the eligibility of committee members for the award and shall nominate a recipient for the approval of Subcommittee 4 and the D01 Executive Committee at its winter meeting. The Award Group shall notify the Secretary of Committee D01 its nomination at least two months prior to the winter meeting and the nomination shall include the name and address of the recipient and a description of the work and the publication for which the award is to be given.
- C. After the D01 Executive Committee has approved the nomination for the award, the Secretary of Committee D01 shall advise the Awards Administrator of the Society of its decision and the Awards Administrator on behalf of the Chairman of the Board shall notify the recipient that he has been selected by Committee D01 to receive the William T. Pearce Award.
- D. The Award shall be conferred upon the recipient at an appropriate occasion at the discretion of the recipient by an officer of the Society or be the Chairman of Committee D01.
- E. The D01 Executive Committee shall have authority to decide any questions not specifically covered by these rules, and the rules may be modified upon recommendation of the Award Task Group.

# **AWARD TO RECIPIENTS**

The William T. Pearce Award shall consist of an ASTM logo mounted on a walnut plaque, with a blue velvet background. The award shall not include a cash honorarium.

Financing of the Award is through voluntary contributions by Committee D01 members

## 12. Euverard Innovation Award – Society Recognized Award

This award was established in 1993 by the D01 Executive Subcommittee. The award was established to commemorate such innovations made by Maynard R. Euverard (1971-1992) of the Paul N. Gardner Company, Inc. in the development of innovative test devices used in standards development under the jurisdiction of Committee D01.

## **CRITERIA**

The Euverard Innovation Award is presented not more than once a year to a member of Committee D01 who has develop an innovative test apparatus or technique or demonstrated sustained technical competence in the development of standards under the jurisdiction of Committee D01.

## **RULES GOVERNING THE AWARD**

- The award will be administered by Subcommittee D01.94 on Awards and Memorials. It shall be awarded not more frequently than once a year.
- Nominations for the award may be made by any D01 member; the nominees are limited to D01 membership.
- Each nomination shall include a statement justifying the consideration of the nominee for the award and specifying the test apparatus or technique that the nominee has either developed or been instrumental in incorporating into a D01 standard.
- Nominations shall be in writing and furnished to the Chair of D01.94, Subcommittee on Awards and Memorials, preferably during the January meeting of each year.

## THE AWARD

The Euverard Innovation Award shall be commemorated with a wall plaque installed at ASTM Headquarters, with the name of the recipients of the award. Each recipient of the Euverard Innovation Award shall receive a personal hand plaque with the following inscription:

# Committee D01 on Paint and Related Coatings, Materials, and Applications Euverard Innovation Award

This award was established by Committee D01 in 1995 in honor of Mr. Maynard Euverard of the Paul N. Gardner Co., and is given in recognition of the development of an innovative test apparatus or technique used in the advancement of a standard under the jurisdiction of Committee D01.

## **FUNDING**

A generous endowment of \$5,000 was given to Committee D01 by the Paul N. Gardner Company, Inc. for this award. As of June 1994, the fund contained \$5,000 and the present goal of D01 is to cause this fund to be sustained at approximately \$5,000. D01 plans to spend approximately \$100.00 for the plaque maintained at ASTM Headquarters. By maintaining \$5,000 in the fund, it should accrue at least \$300 per year, resulting in this money being available for the personal award and honorarium on a yearly basis.

**13. Award of Merit-** established by the ASTM Board of Directors in 1949, is the highest Society award granted to an individual for distinguished service and outstanding participation in ASTM International committee activities. Recipients also receive the honorary title of Fellow. The deadline for nominations is November 1<sup>st</sup> of each year. Presentations are made by the Board Chair of ASTM or a designated representative.

## Establishment of the Award

The ASTM Board of Directors established the Award of Merit in 1949 to recognize distinguished service to the Society by individual members. The award is granted solely on merit.

Due to the prestigious stature of the award, it is recommended that a committee submit no more than one nomination in a given year.

## Basis of the Award

Any or all of the following types of service shall be considered as the basis for nominating an individual for the Award of Merit:

- Unusually productive service in ASTM committee work over a substantial period of time.
- Significant technical contributions in authoring new standards or revisions to existing standards
- Marked leadership or mentoring in administrative or special activities at the subcommittee, committee, or Society level.
- Outstanding contributions in the areas of research or testing, leading to new standards development.
- Symposium or publication activities of special benefit to the work of a committee or the Society.
- Any other outstanding service or activity that has greatly enhanced the prestige or standing, and advanced the interests of, a particular committee or the Society as a whole.

## **Preparation and Submission of Nominations**

- All nominations shall follow the Guidelines for Preparing Award of Merit nominations provided annually to all committees by ASTM International headquarters.
- A nomination shall be developed by either an Ad Hoc Committee of the Executive Subcommittee or an Awards Subcommittee, in each case consisting of at least three members.
- If a nominee has made significant contributions in more than one Committee, the Committees may work together to prepare the nomination, but one Committee must be selected as the sponsor.
- Nominations are to be submitted to the Award of Merit Selection Committee in care of Maryann Zamorski (<u>mzamorski@astm.org</u>). All nominations are to be received by November 1<sup>st</sup> of each year. Nominations received after this date will be held for consideration in the following year.
- To be eligible, a nominee shall be a member of the Society both in the year the nomination is submitted and the year in which it is reviewed by the Award of Merit Selection Committee and shall be living at the time of the submission cut-off date. An individual is only eligible to be awarded the ASTM Award of Merit one time.

• Current Executive Subcommittee Members of the Board of Directors and ASTM International employees are not eligible to receive the ASTM International Award of Merit.

# **Award of Merit Selection Committee**

- The Award of Merit Selection Committee shall consist of the Senior Vice-Chair of the ASTM International Board of Directors, and six other members appointed by the Board Chair of the ASTM Board of Directors to three-year, staggered terms of office.
- The Senior Vice-Chair of the Board of Directors each year shall serve as Chair of the Award of Merit Selection Committee.
- The Award of Merit Selection Committee shall meet to consider all the nominations for a given year in January of that year.
- The Award of Merit Selection Committee must determine that the nominee has performed distinguished, and not
  just expected service to ASTM International based on the information contained in the nomination. In addition, the
  Award of Merit Selection Committee shall ensure that the "Guidelines" have been followed and the "Basis of the
  Award" has been documented adequately.
- All members of the Award of Merit Selection Committee shall be entitled to a vote, and a simple majority shall be required for acceptance of each nomination.
- The Chair of the Award of Merit Selection Committee shall report the actions of that committee to the Executive Committee of the ASTM International Board of Directors, and the Executive Committee shall provide a final report to the full Board for information.

# Form and Presentation of the Award

The award shall consist of a walnut plaque designating the recipient a Fellow of the Society and an ASTM International lapel pin/tie tack.

Presentation of the ASTM International Award of Merit should be scheduled at the convenience and discretion of the recipient during the year in which it was approved, preferably at an ASTM International committee meeting or special awards banquet.

The following are examples of excellent citations:

"For outstanding contributions and leadership in developing standards related to gypsum products and their installation, and in the overall operation of ASTM International Committee C11 on Gypsum and Related Building Materials and Systems"

"For meritorious and dedicated service to ASTM International Committee F15 on Consumer Products with a strong commitment to the pursuit of safer products via standards development, especially in the area of juvenile products, and for respected technical expertise, outstanding leadership and exemplary professionalism"

# **A FINAL WORD**

An Award of Merit nomination is not in competition with other Award of Merit nominations. Nominating Committees are encouraged to work together with other committees if the nominee has performed distinguished service in multiple committees.

The commitment of ASTM International's members to their standards development work is crucial to the continued success of the technical committees and the Society as a whole. Submitting a well-written Award of Merit nomination can lead to this success by focusing on the technical contributions of your nominee.

Please remember that the Award of Merit Selection Committee Members do not know your nominee. They must determine that a nominee has performed distinguished and not just expected service to ASTM International based solely on the information you provide in a nomination.

The nominee must be a member of ASTM International at the time the nomination is submitted and the year in which it is reviewed by the Award of Merit Selection Committee.

The nominee must be alive at the time of the submission cut-off date for the Award of Merit.

Please try to avoid the following occurrences:

- A nomination that is too brief and does not provide adequate information on specific technical service and contributions to ASTM International.
- A nomination in which the same facts and figures are repeated throughout the nomination.
- A nomination that lists information on the nominee's achievements not relevant to ASTM International, such as contributions to his/her employer or other organizations.
